Which would be kind of a more permanent interim body, but unfortunately none, no, no efforts to create standing resolutions past at this convention. So instead, we had a resolution on creating a task force and imagining a church grounded, and creation healing as Christian ministry, which was originally submitted by Jerry, and then kind of reworked to be something quite different. So thank you.

Uh Jerry for submitting that, and then I know it got changed, and this will be a churchwide committee, with at least with 16 members, at least 8 people of color, and at least.

Committee will have all sorts of responsibilities to guide the Church on creation and to help allocate um small grants for ecosystem projects. But a second dairy taskforce was created as well, and this was, I think, a really impactful um moment where um in the House of Bishops to indigenous bishops, Mike Scott.

And Carol Gallagher both got up to say that they really wanted to make sure that there was a task force specifically with indigenous Episcopalians guiding the Church on creation, and so that resolution was passed as well. And this is going to be the 1st time we have this kind of a indigenous task. Force on creation, care.

Everything that is marked in green is a budget request. Um. But there is a process this fall that in involves leadership in the House of Deputies.

Um and the new presenting Bishop and the Budget Committee. Um, on determining which of these budget requests are actually heard. Some of you may have heard that there's typically about 2 million dollars um to be allocated to these requests.

And sometimes upwards of 9 or 10 million dollars, and the total request for creation care.

That sort of is the sum of all of these notes in green. Here is \$550,000 um for the triennium, and so uh, it won't be determined until September. Um, whether these are actually funded. But I wanted to mark which ones are requests. Um.

Jerry and I were talking about how these networking and net 0 resolutions have a lot of potential for involvement from provinces 4 and 5.
